Since 1981, National Crime Victims' Rights Week is commemorated every year in April. This week is dedicated to learning about victimization, the effect victimization has on individuals, families, friends and the community, and to promote laws, policies and programs to help victims of crime, for which I am all too familiar.

I started my journey with Shelby County Government in 2001 as the Executive Director of the Crime Victims' Center (CVC). The Crime Victims' Center is a comprehensive victim services agency that serves all victims of crime with dignity and respect. The Center has now grown to include the Rape Crisis Center and continues to strive to be an organization that provides counseling, advocacy, resources, and education to those victimized, directly and indirectly, by crime and violence within our community. After seven years at the CVC, I was promoted to the position of Deputy Director of Community Services, overseeing all Victim and Offender services. My experience serving victims of crime and their families gave me a different perspective while in this position. especially with being over Pre-Trial Services, which included Probation and Parole.

Fourteen years later and still within Shelby County Government as the Criminal Court Clerk, I value my experience working with victims and offenders. I know it has afforded me an opportunity to see and understand different aspects of crime and I truly believe we need justice reform for victims and offenders. However, April is about supporting and assisting crime victims with their healing. 


